2. COMPOSITION AND COMPONENTS DATA

COMPOSITION COMMENTS: Aqueous polymer dispersion containing inert organic fillers and additives.

3. HAZARDS IDENTIFICATION

HAZARD IDENTIFICATION: Not classified as hazardous under current regulations.

4. FIRST AID MEASURES
